Proposed Action

That the Metropolitan Council authorize the Regional Administrator to execute a CY2012 capital grant agreement for the Central Corridor Light Rail Transit (LRT) project for right-of-way acquisition, fare collection equipment, construction and purchase of Light Rail Vehicles in the amount of \$97,879,633.

Background

Counties Transit Improvement Board (CTIB) was created in 2008 by enabling state legislation and the concurrence of five counties in the region (Anoka, Dakota, Hennepin, Ramsey, and Washington) to levy a one-quarter percent sales tax. Its purpose is to provide a dedicated revenue source for capital and operating funds for transitway projects serving the five participating counties. CTIB previously approved grants for the Central Corridor LRT project in the amounts of \$13,362,366 for CY2009, \$66,026,475 for CY 2010 and \$106,681,526 for CY 2011.

On Oct. 26, 2011 the Council approved Business Item 2011-280 finding the grant application consistent with the adopted 2030 Transportation Policy Plan.

Rationale

CTIB capital grant funds for the Central Corridor LRT project will contribute to the successful implementation of the Council's 2030 Transportation Policy Plan, which lists Central Corridor LRT as a Tier I transitway. CTIB grant funding allows the Council to take advantage of this funding source and reduces the need to secure additional capital funds from other local funding sources. This CTIB grant is the fourth and final installment thus fulfilling CTIB's full \$284 million local share contribution.

Funding

CTIB requires that capital projects maximize the use and availability of federal funds and have a 10% local contribution from the state. CTIB grant funds will provide 30% (\$284 million) of overall capital funding and will be used in conjunction with other local sources of funding available to the Central Corridor LRT Project, including funding from the State of Minnesota (10%), the Ramsey County Regional Railroad Authority (7%), and the Hennepin County Regional Railroad Authority (3%).

Known Support / Opposition

On November 16, 2011, CTIB authorized award of a capital grant to the Central Corridor LRT Project in an amount of \$97,879,633.
