Consent List

2011-334 Hiawatha Light Rail Vehicle Passenger Door

"That the Metropolitan Council authorizes the Regional Administrator to purchase passenger door overhaul replacement parts for the Blue Line (Hiawatha) light rail vehicles in an amount not to exceed \$650,000 over a two-year period."

2011-353 Authorizatin to Exercise Contract Options with Motor Coach Industries

"That the Metropolitan Council authorize the Regional Administrator to exercise existing contract options on contract 08P114 with Motor Coach Industries (MCI) to purchase six coach buses in an amount not to exceed \$3,244,800."

2011-362 Authorization for Sole Source Procurement from Alfa Laval for Original Equipment Manufacturer (OEM) Parts

"That the Metropolitan Council authorize its Regional Administrator to procure DS 706 centrifuge backdrive system upgrades from the original equipment manufacturer (OEM) on a sole source basis from Alfa Laval for ten existing centrifuges. This is for an amount not to exceed \$750,000 over a three-year period."

2011-363 Authorization to Negotiate and Execute an Amendment to the Construction Cooperation and Cost Sharing Agreement with the City of East Bethel, MCES Project Nos. 801620 and 801621, Contract No. 101017

"That the Metropolitan Council authorize its Regional Administrator to negotiate and execute an amendment to the Construction and Cost Sharing Agreement with the City of East Bethel, MCES Project Nos. 801620 and 801621, Contract No. 101027."

2011-364 Bassett Creek Regional Trail Master Plan, Three Rivers Park District, Referral No. 50013-1

"That the Metropolitan Council:

- 1. Approve the Bassett Creek Regional Trail Master Plan (Referral No. 50013-1).
- 2. Require that prior to development of new trail segments, development plans be sent to Metropolitan Council Environmental Services for review and comment in order to ensure the integrity of the interceptor system.
- 3. Advise Three Rivers Park District that the construction costs described in the master plan for Segment D (striping a bike lane along Nevada Avenue) and for Segment E6 (reconstruction of the existing trail parallel to TH 100 as part of a future residential subdivision) are not eligible for regional parks funding."

2011-365 Scott West Regional Trail Master Plan, Scott County, Review No. 50011-1 "That the Metropolitan Council approve the Scott West Regional Trail Master Plan."

2011-366 Reimbursement Consideration Request for Completing Nature Play Area at Bald Eagle-Otter Lake Regional Park, Ramsey County

"That the Metropolitan Council authorize Ramsey County to expend up to \$150,000 of its own funds for the construction of the remaining Tamarack Nature Center Play Area elements consisting of the gathering shade arbor, tunnel/climbing features and interpretive signage at Bald Eagle-Otter Lakes Regional Park. This project is proposed to be funded from the County's share of the SFY 2013 Parks and Trails Legacy Fund appropriation. The County will not be reimbursed for its expenses from the SFY 2013 Parks and Trails Legacy Fund appropriation until the appropriation is available and after execution of a grant agreement for this project."

2011-369 Sciota Township 2030 Comprehensive Plan Update, Review No. 20827-1

"That the Metropolitan Council adopt the attached Advisory Comments and Review Record, and the following:

- 1. Authorize Sciota Township to put its 2030 Comprehensive Plan Update into effect.
- 2. Advise the Township to implement the advisory comments for Subsurface Sewage Treatment Systems (SSTS) and Parks."

2011-358 Central Corridor Light Rail Transit (Green Line): 2012 Counties Transit **Improvement Board Capital Grant**

It was moved by Elkins and seconded by Đoàn

"That the Metropolitan Council authorize the Regional Administrator to execute a CY2012 capital grant agreement for the Central Corridor Light Rail Transit (LRT) project for right-ofway acquisition, fare collection equipment, construction and purchase of Light Rail Vehicles in the amount of \$97,879,633."

Motion carried.

2011-359 Southwest Light Rail Transit (Green Line): CY2012 Counties Transit **Improvement Board Capital Grant**

It was moved by Elkins and seconded by Munt

"That the Metropolitan Council authorize the Regional Administrator to execute a CY2012 capital grant agreement for the Southwest Light Rail Transit (SWLRT) project for Preliminary Engineering (PE) in the amount of \$13,562,000."

2011-360 Authorization to Execute Agreement with Counties Transit Improvement **Board for Transit and Rail Operations**

It was moved by Elkins and seconded by Rummel

"That the Metropolitan Council authorize the Regional Administrator to execute agreements with the Counties Transit Improvement Board (CTIB) to receive operating funds for CY12 for the following projects:

- . Hiawatha LRT - \$12,734,091
- Northstar Commuter Rail \$8,964,925 .
- I-35W BRT \$169,455
- Cedar Ave. BRT Express Service \$453,047
- Cedar Ave. BRT Station to Station Service \$269,909."

2012-5 Metropolitan Council Vanpool Service Re-Branding

1) Approve "Metro Vanpool" as the new name for the Council subsidized vanpool program.

2) Approve the recommended logo and vehicle branding designs, attached."
