### **Proposed Action:**

### Summary of Committee Discussion / Questions:

Melander encouraged staff to consider using Minnesota manufacturer of solar panels. Staff said that issue will be addressed after funding is secured.

Rummel commented on the low attendance at the public hearing and asked about getting better attendance. Staff responded that attendance depends on the nature of the project, and this did not seem to be a high priority for invitees. High attendance has occurred on some projects, especially sewer projects. Council Member Van Eyll said he attended the hearing, and elected local officials were very much in favor of the project – with funding assistance to avoid an impact on wastewater rates.

Motion to approve proposed action was made, seconded, and passed unanimously.

#### Proposed Action/Motion

That the Metropolitan Council adopts the Facility Plan Amendment for the Blue Lake Wastewater Treatment Plant (WWTP) Improvements, MCES Project No. 801800, per the attached Resolution No. 2012-4.

### Background

The facility plan amendment recommends installing a static non-tracking solar photovoltaic system of up to 1.25 Megawatt AC on approximately 15 acres of buffer land owned by the Metropolitan Council and located on the west side of its Blue Lake Wastewater Treatment Plant in Shakopee. The static system was selected as the lowest capital cost alternative compared to single and dual tracking systems. System capacity was selected to not exceed the plant's minimum daytime energy consumption.

The project will include the solar panel facility, consisting of approximately 5,400 modules, electrical connection to the plant's power distribution system, fencing and a small berm for flood protection. The estimated capital cost is \$6.8 million.

The proposed solar system will provide about 13% of the plant's current average electrical load. The project's estimated energy cost savings is slightly over \$100,000 per year. This results in a 25-year net present value (NPV) savings of \$2.6 million.

The total project 25-year NPV cost of \$4.4 million indicates that this project is not cost effective without additional outside funding. Therefore, before constructing the Blue Lake Solar Power Facility, MCES will seek the financial support necessary to improve the Council's lifecycle costs to the break-even point to ensure that additional ratepayer costs are not incurred as a result of this project.

### Rationale

Public Facilities Authority (PFA) funding eligibility requires formal adoption of the Facility Plan Amendment by resolution (attached), following a public hearing on the draft Facility Plan Amendment.

# Funding

Funds for project planning and design are included in the 2012 Capital Program. However if outside financial assistance is not secured, the project will not proceed without additional action of the Council. MCES will submit this project addition to PFA for inclusion in its 2013 Intended Use Plan.

#### **Known Support/Opposition**

A public hearing was held on January 31, 2012. No significant project opposition has arisen. The public comment period ends February 10, 2012.
