### 2012-76 2012-2015 TIP Amendment Request to add FTA Section 5307 funds for I-35E and CR 14 Park & Ride in Lino Lakes (TAB action 2012-09)

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to amend the 2012-2015 Transportation Improvement Program (TIP) to include FTA Section 5307 funds for I-35E and CR 14 park & Ride in Lino Lakes.

# 2012-77 2012-2015 TIP Amendment Request to add federal funds for I-35W westbound auxiliary lane, noise wall, and bridge replacement in Bloomington and Richfield (TAB Action 2012-10)

The Metropolitan Council authorizes its Regional Administrator to negotiate and execute a cooperative agreement between the Council and the City of Golden Valley for the 1-GV-461 Relief Lift Station and Forcemain Project.

## 2012-80 Authorization to Negotiate and Execute an Amendment to Cooperative Agreement 111031 with the City of Golden Valley, MCES Project No. 805700

The Metropolitan Council authorizes its Regional Administrator to negotiate and execute an amendment to Cooperative Agreement 111031 between the Council and the City of Golden Valley for construction of the Circle Down segment of the 1-GV-461 Relief Lift Station and Forcemain Project.

### 2012-70 Metro Mobility Agency Contract Recommendation

It was moved by Elkins, seconded by Munt

That the Metropolitan Council authorize the Regional Administrator to enter into a contract for the operation of Metro Mobility Agency transit service for the term July 1, 2012 through June 30, 2017 with First Transit Inc. in an amount not to exceed \$27,855,940. **Motion carried, with Reynoso abstaining.** 

## 2012-78 2012-2015 TIP Amendment Request to include SP#092-070-001; Procurement and Installation of 76 Electric Vehicle Charging Stations (TAB Action 2011-60)

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to amend the 2012-2015 Transportation Improvement Program (TIP) to include SP#092-070-001: procurement and installation of 76 electric vehicle charging stations in the Twin Cities metropolitan area.

### 2012-86 Application to Host 2014 Rail~Volution Conference, Resolution No. 2012-5
