Proposed Action:

That the Metropolitan Council pass Resolution 2012-12 that authorizes acquisition of fee title ownership and permanent/temporary easements necessary for the 1-GV-461 Relief Lift Station and Forcemain Project 805700; and authorizes Council legal staff to initiate condemnation proceedings for those parcels staff cannot acquire by negotiation.

Summary of Committee Discussion / Questions:

The Committee asked about the location and type of property to be acquired. Staff responded that property is needed from private owners for the new lift station and a portion of the forcemain. The remainder of the forcemain will be in right-of-way.

Proposed Action

That the Metropolitan Council pass Resolution 2012-12 that authorizes acquisition of fee title ownership and permanent/temporary easements necessary for the 1-GV-461 Relief Lift Station and Forcemain Project 805700; and authorizes Council legal staff to initiate condemnation proceedings for those parcels staff cannot acquire by negotiation.

Background

Additional sanitary sewer capacity is required to support growth in the communities of St. Louis Park and Golden Valley. This capacity will be provided by the construction of a lift station in the vicinity of the Golden Valley/St. Louis Park border in SE Golden Valley and the construction of a force main from that location to the discharge location on the existing Plymouth Force Main. Facility planning is complete and detailed engineering design is underway. Fee title ownership, permanent and/or temporary easements are required from several property owners to facilitate the construction scheduled to begin in April 2013.

Rationale

Land acquisition is necessary to implement the proposed interceptor improvements. This action delegates authority to staff to acquire property for the project and to use the condemnation process if necessary to ensure timely project delivery.

Funding

The project cost of \$30,000,000 is included in the 2012 Authorized Capital Program.

RESOLUTION NO. 2012 - 12 RESOLUTION AUTHORIZING ACQUISITION OF FEE TITLE OWNERSHIP, PERMANENT/TEMPORARY EASEMENTS 1-GV-461 Relief Lift Station and Force Main MCES PROJECT 805700

WHEREAS, the Council requires acquisition of fee title ownership and permanent/temporary easements for construction of the 1-GV-461 Relief Lift Station and Force Main,

WHEREAS, the Metropolitan Council hereby finds and declares that it must acquire permanent and temporary easements for construction of the 1-GV-461 Relief Lift Station and Force Main prior to the filing of an award by the court-appointed commissioners;

NOW, THEREFORE, BE IT RESOLVED:

- 1. That the acquisition of fee title ownership and permanent/temporary easements identified in the 1-GV-461 Relief Lift Station and Forcemain plans and specifications is reasonably necessary and convenient for the furtherance of the construction of the project and in the judgment of the Metropolitan Council such acquisition will further the public health, safety and welfare, and be undertaken in accordance with Minnesota Statutes and the Real Property Acquisition Policy of the Metropolitan Council; and
- 2. That the Council hereby directs its Regional Administrator to acquire the fee title ownership and permanent/temporary easements necessary for construction of the 1-GV-461 Relief Lift Station and Force Main by negotiation; and
- 3. That, pursuant to Minnesota Statutes Chapter 473, the Council has the authority to acquire the property interests by eminent domain, the fee title ownership and permanent/temporary easements necessary for construction of the 1-GV-461 Relief Lift Station and Forcemain, if the property cannot be acquired by direct negotiation and that such acquisition be in accordance with the procedures authorized under Minnesota Statutes Chapters 473 and 117, including, specifically, 117.042; and
- 4. That the Council hereby approves and certifies that the total just compensation for the fee title ownership and permanent/temporary easements be acquired for construction of the 1-GV-461 Relief Lift Station and Force Main as indicated in the appraisals submitted to the Council.
