Background

This proposed amendment programs new federal, regional and local funding to capital.

Metro Transit

Reducing Funding Commitments: The proposed amendment reduces the authorized funding by a total of \$21,433,462 on 2 projects. Reduce authorized funding includes \$16,115,367 in Federal funds and \$8,738,668 in Regional Transit Capital. In addition, \$3,420,573 was provided by the City of Minneapolis towards the Downtown Minneapolis Layover Gateway project.

Increasing Funding Commitments: The proposed amendment increases funding and spending authority by a total of \$14,700,000 on 2 projects. Funding for these projects includes \$8.4 million in federal funding and \$6.3 million in regional funding. One of the projects, for a Public Facilities Maintenance Building, is new to the capital improvement program.

Net Change in Authorization: \$ (6,733,462) for new continuing projects.

Net Change to Current Year Budget: Based on the timing of projected expenditures, the 2012 Capital Budget is proposed to decrease by \$17,233,462.

Rationale

This proposed amendment programs federal, regional and local funds and increases multi-year spending authority. These capital projects will allow the Council to carry out its long-term capital improvement program for transit.

Fiscal Impact

The proposed amendment decreases regional bonding for Metro Transit projects by \$2,438,668. There is available, un-programmed regional bonding authority provided by the Legislature to accommodate the additional bonding.

The regional funding included in this proposed amendment was reflected in the adopted 2012-2017 Capital Improvement Program and related fiscal analysis.

Background

This proposed amendment authorizes new federal, local and regional funding for new projects as detailed in **ATTACHMENT 1**.

Metro Transit

Closing Projects/Reallocate/Adjust Authorized Funding:

None

Reduce Authorized Funding:

Bus Procurement 40Ft Replacement – Project #61611

This amendment reduces \$16,115,367 in Federal Funds and \$3,300,738 in RTC Funds for the procurement of 45 buses authorized in August 2012 which had been authorized earlier in the year. This project is in the CIP.

Downtown Minneapolis Layover Gateway – Project #63318

This amendment provides \$3,420,573 of City of Minneapolis Program Income from the Rental of Real Property acquired by the City using funds awarded by the Federal Transit Administration and reduces the need of \$5,437,930 of Council Regional Transit Capital to be used in other Metro Transit capital programs. This amendment adjusts this project to a scope of \$7,800,000 for the Gateway Parking Ramp in downtown Minneapolis for use as a bus layover facility. This project was identified in the CIP.

Increasing Funding Commitments:

Police Facility – Project #63219

This amendment provides \$8,400,000 in Federal Funding and \$2,100,000 in RTC Funding for design, potential land acquisition and construction of a new Metro Transit Police Facility. This request was identified in the CIP.

Public Facilities Maintenance Building – New Project #

This amendment provides \$4,200,000 of RTC Funding for design, engineering, land acquisition, construction or purchase of a Public Facilities Maintenance Building. This is a new project to the CIP.

Change to Current Year Expenditures:

Based on projected expenditures for the proposed amendments, the 2012 Capital Budget is proposed to be decreased by \$17,233,462 for Metro Transit.

Rationale

This amendment is required to reduce Federal and RTC Funding while authorizing Other Local Funding for existing and new projects within the Transportation Division's Authorized Capital Program. These activities will allow the Council to carry out its long-term capital improvement program for transit.

Fiscal Impact

This amendment removes \$7,715,367 in Federal funds and \$2,438,668 in RTC Funds and provides \$3,420,573 in Other Funds from the Authorized Capital Program for transit projects.
