2012-326 DBE ES Goal Methodology

"That the Metropolitan Council approve the Disadvantaged Business Enterprise (DBE) PFA Program 2013-2016 goal for submittal to the U.S. Environmental Protection Agency (EPA). The Office of Equal Opportunity (OEO) staff recommend the Council approve the DBE Program goal of 12%-6% women owned DBE and 6% minority owned DBE. OEO also requests the ability to set goals for Minnesota Public Facilities Authority (PFA)/EPA funded construction contracts on an individual contract basis."

2012-353 Scott County 2011 System Statement Comprehensive Plan Amendment, Review File No. 20402-4

"That the Metropolitan Council:

- 1. Adopt the attached review record and allow Scott County to put the 2011 System Statement comprehensive plan amendment (CPA) into effect.
- 2. Advise the County to implement the advisory comments in the Review Record for Parks and forward the corrected maps to the Metropolitan Council staff following the County Board approval.
- 3. Find that the proposed CPA does not change the County's forecasts."

2012-354 Rosemount Greenway Regional Trail Master Plan, Dakota County (Referral No. 50028-1)

"That the Metropolitan Council:

- 1. Approve the Rosemount Greenway Regional Trail Master Plan (Referral No. 50028-1).
- 2. Require Dakota County to send the greenway trail preliminary plans to Scott Dentz, Interceptor Engineering Manager, to assess the potential impact to the Metropolitan Council's interceptors prior to initiating the project.
- 3. Request that Dakota County consider the references to infiltrating stormwater in vulnerable wellhead protection areas as noted in this memorandum."

2012-355 Vermillion Highlands Greenway Regional Trail Master Plan, Dakota County (Referral No. 50029-1)

"That the Metropolitan Council:

- 1. Approve the Vermillion Highlands Greenway Regional Trail Master Plan.
- 2. Require Dakota County to provide trail alignment and development plans to the Metropolitan Council Environmental Services Interceptor Engineering Manager for review to protect regional wastewater interceptor facilities.
- 3. Request that Dakota County consider the referenced documents regarding groundwater and surface water management concerns."
