### Wind Power Feasibility

Doug Maust, Hammel, Green & Abrahamson (HGA), provided a general assessment of the potential for the Council to use wind power. Examination of the Empire Plant and Metro Plant locations revealed that neither site provided a viable setting for wind generation.

### **Energy Work Plan**

Jason Willett, ES Finance Director, summarized the 2006 accomplishments and the 2007 work plan of the Environmental Services Energy Team, whose goal is to reduce energy use by 15% by 2010 and increase the use of renewable energy.

### Minnesota Counties Energy Task Force (MCETF)

Jason Willett explained that the Metropolitan Council is partnering with the MCETF to address issues relating to energy policy and securing energy that is safe, reliable, economical, and environmentally responsible. Willett reviewed the accomplishments of the task force in 2006 as well as its work plan for 2007.
