#### 2008-2017 Preliminary Capital Finance Plan

Jason Willett, MCES Finance Director, reviewed the proposed 2008-2017 Capital Finance Plan which will be incorporated into the Council's Unified Capital Budget for approval as part of that process. Willett noted that the proposed finance plan includes a capital plan of \$1.554 billion; debt service is projected to be 42.3% of the total MCES annual budget expenses in 2008, increasing thereafter until peaking at about 50% in ten years; and also includes \$3 million of pay-as-you-go in the 2008 budget.
