2007-314 Certification that Oakdale Lift Station L11 is in Good Operating Condition

It was moved by Wittsack, seconded by Susag that the Metropolitan Council certifies that Oakdale Lift Station L11 is in good operating condition. **Placed on Council Consent List.**

2007-307 2007 – 2012 Capital Improvement Program and Capital Program and Budget Amendment It was moved by Wittsack, seconded by Susag that the Metropolitan Council amend the MCES 2007 Capital Budget (annual appropriation) by increasing it from \$131,600,000 to \$145,000,000. **Motion carried.**

2007-315 Authorization to Negotiate Purchase Agreement for Future Crow River Wastewater Treatment Plant Site

It was moved by Wittsack, seconded by Beach that the Metropolitan Council authorizes its Regional Administrator to negotiate a purchase agreement for the future Crow River Wastewater Treatment Plant site, MCES Project No. 801640.

2007-316 Authorization to Execute Purchase Agreement with Star Environmental for Septage Facility in Fridley

It was moved by Susag, seconded by Wittsack that the Metropolitan Council authorizes its Regional Administrator to execute a purchase agreement with Star Environmental for its septage facility in Fridley. **Motion carried.**

2007-317 Authorization to Amend Construction Cooperation Agreement with University of Minnesota for Oak Street Interceptor Phase 1

It was moved by Wittsack, seconded by Susag that the Metropolitan Council authorizes its Regional Administrator to negotiate an amendment to the construction cooperation agreement with the University of Minnesota for Oak Street Interceptor Phase 1 to reflect actual construction costs, which increases the total Council project cost from \$2,619,055 to \$3,119,914.
