Proposed Action

That the Metropolitan Council ratify the attached Justification for and Declaration of Emergency for flood preparation and protection.

Background

Flood conditions are projected for the Minnesota River, affecting the Blue Lake Plant during March-April, 2010. Due to the status of construction projects at the Blue Lake Plant, the plant's flood protection system is not fully functional: (1) a portion of the flood levee is under reconstruction; (2) only two of three effluent pumps are available for service; and (3) permanent pumps have not yet been installed in the recently deepened groundwater dewatering wells.

Flood levels are projected to reach the Blue Lake plant by mid-March, with a projected flood crest in early April. The construction work cannot be completed that soon. Consequently, pumps need to be rented to provide backup effluent pumping and to supplement the groundwater dewatering system. Levee reconstruction is being expedited, but temporary emergency measures to ensure plant protection are likely to be needed.

Flood conditions are also projected for the Mississippi River, affecting the Metropolitan Plant. Because river levels may reach the elevation of Childs Road, construction of a temporary access road between Warner Road and the top of the influent double barrel interceptor will be required to provide plant access. Access road preparations must be undertaken in March to ensure Metropolitan Plant access.

Rationale

Metropolitan Council has delegated authority to the Regional Administrator to declare emergencies on behalf of the Council when the health, safety or welfare of the public is compromised or potentially compromised, and immediate action is required to address the emergency. The emergency declaration is then presented to the appropriate implementation committee for approval, and place on a following Council consent list for formal ratification.

Funding

Estimated cost for the flood preparation and protection measures is \$400,000.

Justification for and Declaration of Emergency

"A declared public emergency is an emergency situation in which the health, safety or welfare of the public or the safety of Metropolitan Council employees or facilities is compromised or potentially compromised and requires immediate action to correct."
