## **Discussion of MCES Preliminary 2011 Budget Concepts**

Jason Willett, Environmental Services Division Finance Manager, and Kay Dawson, Budget and Analysis Manager, presented several concepts for discussion: Service Availability Charge (SAC) shift assumptions, key operating budget factors, and recommendations of the Reserve Capacity/SAC Task Force. Staff is looking for resolution of conceptual issues today for presentation at the public meetings. At the committee's direction, staff will adjust the SAC unit collection assumption to 6,500. ES Preliminary Budget and rates will be presented to the Environment Committee on June 8, and public meetings will be held in June.
