2011-130 Authorization to Hold a Public Hearing on the Sewer Availability Charge (SAC) Transfer Amount which Impacts SAC and Wastewater Reserves

It was moved by Melander, seconded by Đoàn, that the Metropolitan Council authorizes staff to schedule and hold a public hearing to gather public input on the Sewer Availability Charge (SAC) Transfer Amount proposed for the 2012 MCES Budget.

2011-131 Authorization for Reserve Designation
