2012-223 2012 Unified Operating Budget Amendment

2012-257 Authorization to Award and Execute Construction Contract for MWWTP Process Equipment, MCES Project Numbers 805921, 805929, 805955; Contract No. 12P074

It was moved by Van Eyll, seconded by Đoàn, that the Metropolitan Council authorize its Regional Administrator to award and execute a Construction Contract for MWWTP Process Equipment, MCES Project Numbers 805921, 805929, 805955, Contract No. 12P074, with Total Mechanical Services in the amount of \$4,483,105.

INFORMATION

- 1. Other Post Employment Benefits (OPEB) Study. Jason Willett, ES Finance Director, explained that OPEB is all retiree benefits that are not part of pension plans, e.g. healthcare, dental, life insurance. Environmental Services eligible positions are expected to be fully funded in a year or so.
- 2. 2013 Capital Program. Bryce Pickart, Assistant General Manager, explained the Capital Program strategy and objectives. He reviewed the proposed 2013-2016 Capital Improvement Program, which includes key projects at the Empire, Metro and East Bethel plants, and interceptor system rehabilitation projects. The proposed 2013 Authorized Capital Program includes six new projects, adjustments to existing projects, deletion of completed projects, and authorization of the design phase for the

Empire Plant solids project and Minneapolis interceptor 1-MN-310/320 diversion project. The proposed 2013 capital budget is \$147 million.

3. General Manager's Report

At Leisa Thompson's request, Bryce Pickart gave an update on East Bethel, and said that Council staff is meeting with the city to discuss issues.

Thompson informed the committee that a discrepancy was found in the Hugo/Forest Lake flow meter, and it appears that each city will receive a credit or refund.

Business completed, the meeting adjourned at 5:05 p.m.
