BUSINESS

Technical Amendments to Legal Services: No Budget Impacts

Don Mueting, General Counsel, presented this business item. The proposed amendments for two legal contracts were explained. These contract increases would allow the General Counsel to pay for essential legal services.

It was moved by L. Wittsack, seconded by S. Broecker:

"That the Metropolitan Council authorizes the General Counsel to amend legal services agreements to increase the maximum contract prices as follows:"

Authorization to Implement the Effect of the Teamsters Local #320 (Full Time Police) Interest Arbitration Outcome

This business item was presented by Sandi Blaeser, Assistant HR Director, Employee Relations. The Teamsters contract expired on December 31, 2008. The arbitrated award was received on June 29, 2010. The arbitrator awarded no general wage increases in either year of the agreement. The labor agreement met the parameters and budget established by the Council.

There were questions about the number of police officers within the Council. Wes Kooistra agreed to have this information provided to Committee Chair, Scherer and other Management Committee members.

It was moved by T. Pistilli; seconded by K. Sanda:

"That the Metropolitan Council authorize the Regional Administrator to implement the effect of the interest arbitration outcome effective for the period January, 2009 through December 31, 2010."

Motion carried.

INFORMATION

Other Post Employment Benefits – Actuarial Valuation as of January 01, 2010

Mary Bogie, Deputy Chief Financial Officer, presented a detailed slide presentation of OPEB (Other Post Employment Benefits.) This is the retiree health plan which includes health care, dental, life insurance and other options. Overall it is a good news story since the Council funding plan balances operating needs with need to fund future obligations. Ms. Bogie explained the difference between "explicit benefit" (employer pays benefits) and "implicit rate subsidy" (retiree pays premium.) Details were shown on the council funding policy; actuarial accrued liability; actuarial gains and losses; projected OPEB and funding; funding plan and the 2010 Operating Budget impact; demographics; and comparisons to other entities.
