### **Proposed Action/Motion**

That the Metropolitan Council:

- Approve the list of projects recommended for funding under the federal Jobs Access Reverse Commute (JARC) and New Freedom programs.
- Authorize the Regional Administrator to apply for and accept grants from Federal Transit Administration (FTA) for up to \$1,466,293 for the JARC program and up to \$1,028,308 for the New Freedom program to fund the recommended projects.

#### Issue(s)

- The funding period for the recommended projects is from October 1, 2007 to September 30, 2009. Projects may begin accruing costs on October 1, 2007. The federal program requirements specify that projects must be selected through a competitive solicitation prior to accruing costs.
- The New Freedom program solicitation received fewer requests than money available. As a result, an additional 25% of federal funds were offered to recommended projects. This additional funding will cover expansion of applicants' initial requests and/or administrative costs in overseeing the grants. The additional funding must not change the scope of the project, nor extend the timeframe.

#### Overview and Funding

The 2006-2007 JARC and New Freedom solicitation received 17 applications, 11 for JARC and 6 for New Freedom. The New Freedom project applications totaled less than the money available under the solicitation and thus, after the project eligibility was verified all projects were recommended for funding. The JARC applications were reviewed and scored by a committee of eight stakeholders. The top nine projects were recommended for awards. The following lists summarize the project recommendations:
