**SUBJECT:** Switching the program years for three HSIP projects in the 2011-2014 Transportation Improvement Program

**MOTION:** That the 2011-2014 Transportation Improvement Program (TIP) include Scott County SP#70-617-23 in Program Year 2013, Anoka County SP#02-596-20 in Program Year 2014 and Ramsey County SP#62-631-10 in Program Year 2014.

**BACKGROUND AND PURPOSE OF ACTION:** During the public comment period on the draft 2011-2014 TIP, Scott County requested that the Highway Safety Improvement Program (HSIP) project at CSAH 17 and CSAH 42 be moved from program year 2014 to 2013. Staff inquired with MN/DOT Metro State Aid if a switch with another project was possible, but they were not able to identify a project to switch program years.

Scott County contacted other project sponsors and asked to switch program years. Anoka County agreed to move the CSAH 3 @ Springbrook project and Ramsey County volunteered to move Maryland Ave @ Arkwright Ave project back to 2014. Since this program year switch was arranged after the close of the public comment period on the draft 2011-2014 TIP, this action is forwarded separately from the adoption and adjustments recommended for the draft TIP.

The federal amount of the Scott County project in program year 2013 and adjusted for inflation is \$1,836,000. The amount of the Anoka County project in program year 2014 is \$468,000, and the amount of the Ramsey County project in program year 2014 is \$1,417,818. These changes will be reflected in the final 2011-2014 TIP.
