**Proposed Action**

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to amend the 2010-2013 Transportation Improvement Program (TIP) for MnDOT SP#6280-308RW1: I-35 E from I-94 through Maryland Avenue including Cayuga Bridge Right of Way Purchase.

**Background**

MnDOT is attempting to advance this Chapter 152 Bridge(s) project to 2011.

**Rationale**

In order to spend Federal Transportation Funds, the project must be accurately reflected in the current TIP.

**Funding**

The federal funds (\$4,800,000) come from two projects no longer in the TIP:

SP 6225-10: TH 96 from TH 61 to TH 95

Due to a positive balance in the State Road Construction budget late in SFY 2010, MnDOT determined to fund the project with SFY 2010 funds.

SP 6227-57: TH 120 from I-94 to Conway Ave.

The project is not ready to be let in SFY 2011 so it is being deferred to SFY 2012 during development of the 2011-2014 TIP/STIP.

MnDOT trunk highway funds will be used for the local match.

**Known Support / Opposition**

There was no opposition noted at the TAC or TAB.



**PROJECT BACKGROUND:**

1. Briefly describe why amendment is needed (e.g., project in previous STIP but not completed; illustrative project and funds now available; discretionary funds received; inadvertently not included in STIP).

This amendment is needed to add project 6280-308RW1 to the 2010-2013 STIP in SFY 2011. The project will fund Right of Way needed for constructing the Cayuga Bridge. Originally the Cayuga project was identified for construction in SFY 2015, which was outside the current STIP funding. However, the decision has been made to move the project into SFY 2012. This created the need for Right of Way funds to be identified in the current STIP so property offers and acquisition can be started in SFY 2011.

\*To maintain Fiscal Constraint, two projects are no longer identified in SFY 2011. Project 6227-57 (Seq. #1801) is moving from SFY 2011 to SFY 2012 which leaves \$1,044,320 federal funds available. Also, project 6225-10 (Seq. #1797) was advanced from SFY 2011 to SFY 2010 leaving \$3,896,000 federal funds available. The two projects federal funds totals \$4,940,320 which provides the \$4,800,000 needed to identify project 6280-308RW1 in SFY 2011. Trunk Highway funds will be used for the 20% state match of \$1.2M.


