In March 2007, Local Planning Assistance sector representatives sent a survey to region's cities and townships which asked the anticipated year/quarter the 2008 comprehensive plan updates (CPU) would be submitted to the Council for review.

A total of 159 of the 182 cities and townships (approximately 87%) responded to the survey. The below provides a summary of anticipated submittal dates by year and then by quarter.

General City/Township Summary:

Nearly half of the 182 cities and townships will submit their comprehensive plan updates between July and December 2008.

Most of the cities and townships in Carver County plan to submit their comprehensive plan updates in the second quarter (April-June) of 2008 and most of the cities and townships in Scott and Dakota counties plan to submit their comprehensive plan updates in the third quarter (July-September) of 2008 (see Attached map).

There were two communities, Scandia and Pine Springs, that indicated they will submit their comprehensive plan updates after the December 2008 deadline.

County Planning

The following is a summary of the anticipated submittals of county comprehensive plan updates. Dakota County anticipates that they will submit in the first quarter (Jan-March) of 2008; Anoka, Scott, and Washington counties in the third quarter (July-September) of 2008; and Carver County in the fourth quarter (October-December) of 2008.

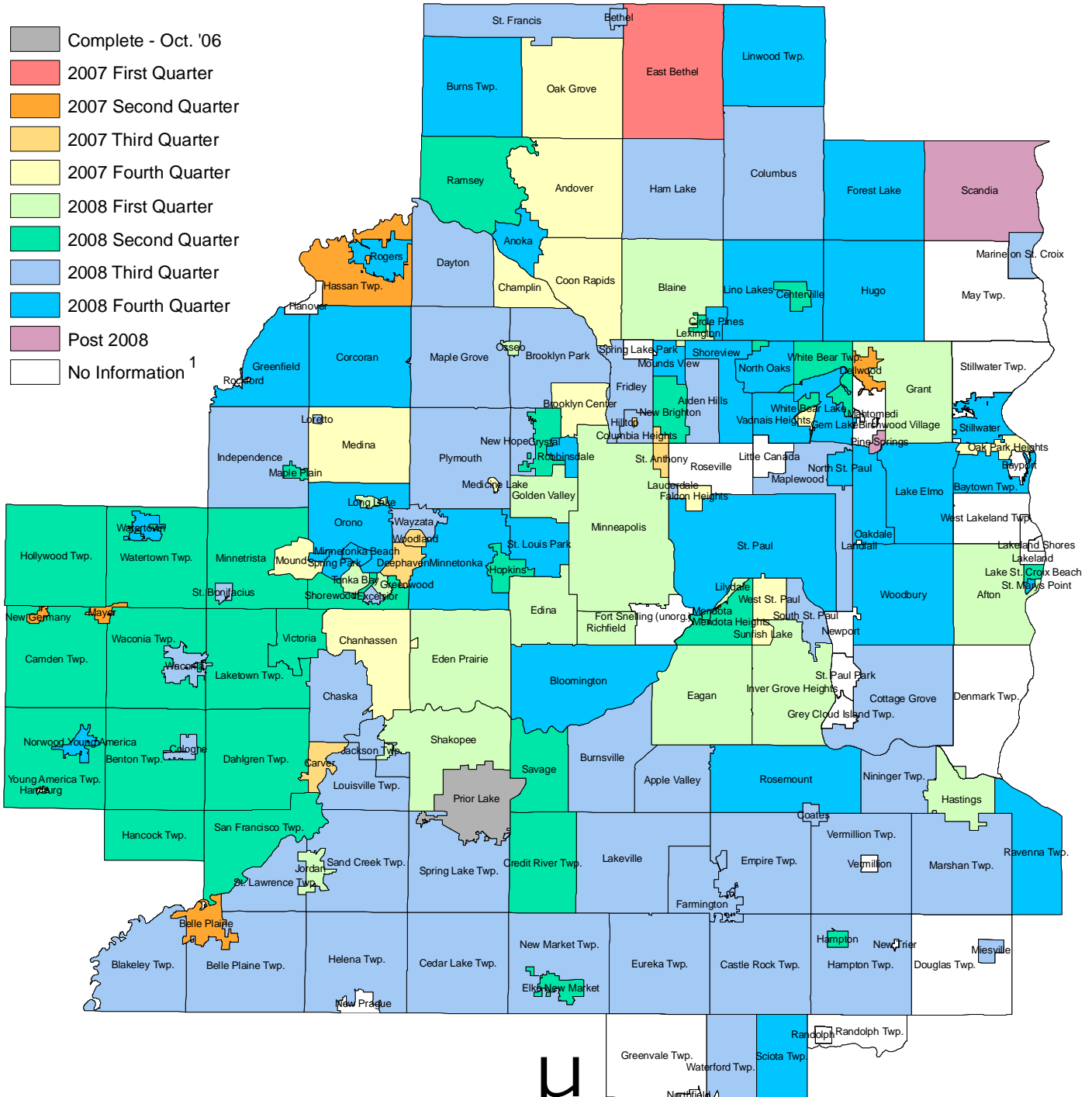
