### **Proposed Action/Motion**

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to amend the 2007-2010 TIP and the Draft 2008-2011 TIP to include SP# CM-7-BIO: MPCA Pilot Program to Retrofit On-Road Public Vehicles.

### **Issue(s)**

The TAB approved funding this pilot program with \$500,000 CMAQ funds at its September 19, 2007 meeting. The MPCA will provide the local match, which will allow 200 on-road public vehicles to be retrofitted to reduce CO, fine particulate matter and hydrocarbons.

The TIP fiscal balance will be maintained by using the obligation authority for a regionally selected project which has been dropped. This MPCA Pilot Program project is exempt from project and regional air quality conformity analysis, and the project is consistent with the region's Transportation Policy Plan.

**MOTION:** That the Transportation Advisory Board amends the 2007-2010 Transportation Improvement Program (TIP) to include SP# CM-7-BIO: MPCA Pilot Program to Retrofit On-Road Public Vehicles.

**BACKGROUND AND PURPOSE OF ACTION:** The TAB approved funding this pilot program with \$500,000 in CMAQ funding at its September 2007 meeting. The work on this project is to retrofit a minimum of 200 MnDOT, Hennepin County, Ramsey County, City of Minneapolis, and City of St Paul on-road public vehicles with diesel oxidation catalysts. This retrofit will have direct air quality benefits in reducing CO, fine particulate matter, and hydrocarbons. In order for these funds to become available immediately, a TIP amendment is required. MPCA is providing the 20% local match.

**PROJECT BACKGROUND:**

1. Briefly describe why amendment is needed (e.g., project in previous STIP but not completed; illustrative project and funds now available; discretionary funds received; inadvertently not included in STIP).

Reducing emissions from diesel engines is one of the most important air quality challenges facing our country, according to the U.S. Environmental Protection Agency (EPA). The work of this project is to retrofit a minimum of 200 Minnesota Department of Transportation, Hennepin County, Ramsey County and the City of Minneapolis on-road vehicles with diesel oxidation catalysts (DOC's). The total emission reductions from each retrofit are from carbon monoxide (30%), fine particulate matter (20%) and hydrocarbons (50%). This retrofit provides a direct solution for improving regional air quality in the Twin Cities area.

This amendment is needed to identify the project in the current 2007-2010 TIP, using \$500,000 CMAQ funds, contingent on a positive recommendation for funding by the TAB at its September 19, 2007 meeting. The MPCA will provide the 20% match (\$125,000) for the project.

On October 17, 2007 the Transportation Advisory Board (TAB) voted to amend the current 2007-2010 Transportation Improvement Program (TIP) and the draft 2008-2011 TIP to include SP# CM-&-BIO, a pilot project to retrofit on-road diesel powered construction and maintenance vehicles with diesel oxidation catalysts and crankcase filters to reduce harmful pollutants. As part of this action, the TAB has provided \$500,000 of CMAQ funding from the 2007 regional solicitation.

The TAB forwards this action to the Metropolitan Council for concurrence along with additional information described in TAB action transmittal 2007-55.
