**MOTION:** The TAB amended the 2009-2012 TIP to include SP# 82-00138, replace existing rail crossing signals with rail crossing lights and gate at Canadian Pacific rail crossing at Belden Boulevard in Cottage Grove.

**BACKGROUND AND PURPOSE OF ACTION:** This amendment is needed to include this rail crossing safety project in the TIP and STIP in order to use the federal funds awarded for its construction. This project was awarded Section 1103 High Speed Rail (HSR) funds and is nearly ready for letting, but is not in the current TIP. These funds must be authorized for the project by the end of the federal fiscal year 2009 or the Federal Railroad Administration will retract them.



Subject: Section 1103 Federally Funded Project in Metropolitan Area

This request is for the Metro Council TAB to expedite the Metro Council TIP amendment process to allow a Section 1103 (High Speed Rail) funded project to be authorized before the October 1 deadline.

In 1998, the Transportation Equity Act for the 21<sup>st</sup> Century (TEA-21) became law. TEA-21 included federal funding for federally designated rail corridors, including the Minnesota corridor known as the Canadian Pacific Railway (CP) River Subdivision (River sub). The CP River sub is part of the Minneapolis/St. Paul-Chicago segment of the Chicago-Hub Corridor. The funding is divided between the states of Wisconsin and Minnesota. In 2005 the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) increased the set-aside for Wisconsin and Minnesota.

The CP sub highway-railroad grade crossings in the metropolitan area have not been part of the Section 1103 funding because the public crossings have, for the most part, been addressed with the Section 130 rail safety program. Therefore, Section 1103 funding has primarily been used in Mn/DOT's District 6 area along the river sub. As part of the Section 1103 funding, existing equipment has been upgraded or replaced along the corridor. Canadian Pacific Railway identified the Belden Boulevard at-grade crossing in Cottage Grove, Washington County as a priority location for replacement due to the age of the equipment and circuitry.

Section 1103 funding is administered with its own obligation authority -- resulting in no impact to funding targets. All FFY 2009 projects (including Belden Blvd) must be federally authorized prior to the end of the federal fiscal year, October 1, 2009. In order to expend the funds in the Metro area a TIP/STIP amendment must be approved before mid September. If it is not agreeable for the TAB to expedite the TIP amendment for this project, our office will need to replace the Belden Boulevard crossing project with one in Mn/DOT's Rochester District to ensure these Section 1103 federal funds are spent.

Your consideration of expediting the TIP amendment process to spend these funds in the Metro area before the October 1 deadline is very much appreciated.
