**Proposed Action**

Approve I-35W and 46<sup>th</sup> Street Station Service Restructuring Concept Plan for public review.

**Background**

In late 2010, Metro Transit in partnership with Mn/DOT will be opening the first “on-line” bus station on the I-35W corridor at 46<sup>th</sup> Street in South Minneapolis as part of the “Crosstown Reconstruction Project”. The proposed Service Restructuring Concept Plan modifies existing bus routes to better serve the new station.

The I-35W station at 46<sup>th</sup> Street is one of eight stations planned for the I-35W Bus Rapid Transit project. These stations will support all-day service on the freeway in both directions linking neighborhoods initially with downtown Minneapolis, University of Minnesota and south suburban reverse-commute destinations and eventually providing direct access to major destinations east and west of the freeway.

The two-level median station at 46th Street will be served by local routes on the bridge over I-35W while several freeway routes will serve the on-line station by leaving the MnPASS express lane briefly to pick up customers at the station’s platform between the northbound and southbound lanes.

While the full BRT service will not start until 2012, the service in the area of the station will be restructured in late 2010 to make best use of the facility before the start of BRT service. The proposed service restructuring concept plan does change bus service for some customers riding from Edina, Richfield, and South Minneapolis. The biggest impacts will be felt by customers now using routes 135, 146, 152 and 576 as these routes are combined and connecting service is arranged at the new station

Those who travel to the new station on local routes will have improved access to suburban destinations throughout the south suburbs, including, for example, the Best Buy headquarters, Southtown, and Normandale Community College.

## Rationale

These route changes impact greater than 25 percent of a route or group of routes which is defined by Metropolitan Council policy as a "major service change" and requires a public hearing.

The following activities ensure compliance with Council policies.
