Proposed Action

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to amend the 2012-2015 Transportation Improvement Program (TIP) to include St. Croix River Crossing Pre-Construction Projects SP#8217-82045PE (Bridge Plan Design) and SP#8217-82045PR (Peer Review).

Background

This amendment is needed to add pre-construction work necessary to build the St Croix River Bridge, which was previously held up because of a decision by the National Park Service to not approve the project. The project was ultimately approved because of the execution of legislation that exempted the project from the Wild and Scenic River Act. This amendment provides federal funds to both design and prepare bridge plans, special provisions, cost estimates and conduct independent review of the hydraulic analysis for the construction project which MnDOT and WisDOT will use to prepare grading plans for the St. Croix Crossing project.

Rationale

The Transportation Advisory Board approves formal amendments to the Transportation Improvement Program. The Metropolitan Council concurs with the action of the TAB. This project is subject to air quality conformity analysis and was included in the TIP Air Quality Analysis. No changes have been made either to the horizon year or the capacity increase from this project on the regional system. It does not affect fiscal constraint as it uses

existing Advance Construction funds to be paid back in 2014 with federal funds identified in the TIP.

Funding

This project is using state trunk highway funds for Advance Construction (to be reimbursed in 2014 with federal funds), Minnesota State Bonds, High Priority Project (HPP) funds for Wisconsin and Wisconsin State Bonds.

On May 16, 2012, the Transportation Advisory Board voted to amend the 2012-2015 Transportation Improvement Program to include SP#8217-82045PE: St. Croix River Crossing - Prepare Three Bridge Plans and Estimates; Conduct Review of Hydraulic Analysis and SP#8217-82045PR: Peer Review of Bridge Design for Three Bridges.

This amendment will provide federal funds for two projects – \$14 million for the design and preparation of three bridge plans and \$2.5 million for the peer review process of the three plans. These projects are required to design and prepare bridge plans, special provisions, cost estimates and conduct independent review of the hydraulic analysis for the entire-construction project which MnDOT and WisDOT will use to prepare grading plans for the St. Croix Crossing project. The projects are subject to air quality conformity determination which has been previously included in the TIP Air Quality Analysis and no changes have been made to either the horizon year or the capacity increase from this project on the regional system.

The TAB forwards the TIP amendment action to the Metropolitan Council along with additional information described in TAB action transmittal 2012-21.

SUBJECT: 2012-2015 Transportation Improvement Program Amendment Request for MnDOT to add St Croix River Crossing Pre-Construction Work.
MOTION: The TAB adopted an amendment to the 2012-2015 TIP that adds SP#8217-82045PE (Bridge Plan Design) and 8217-82045PR (Peer Review).

BACKGROUND AND PURPOSE OF ACTION: The construction of the St Croix River Bridge was previously held up because of a decision by the National Park Service to not approve the project under the Wild and Scenic Rivers Act. In March 2012, President Obama signed legislation that exempted the crossing from the Wild and Scenic River Act, enabling construction of the bridge to move forward. This amendment will provide federal funds for two projects – \$14 million for the design and preparation of three bridge plans and \$2.5 million for the peer review process of the three plans. These projects are required to design and prepare bridge plans, special provisions, cost estimates and conduct independent review of the hydraulic analysis for the entire-construction project which MnDOT and WisDOT will use to prepare grading plans for the St. Croix Crossing project. These plans require independent design computations along with detail review because the State has determined that the St. Croix Crossing Bridges are a major structure. The bridge plans and peer review projects are being advanced with conversion of federal funds taking place in 2014. The projects are subject to air quality conformity determination which has been previously included in the TIP Air Quality Analysis and no changes have been made to either the horizon year or the capacity increase from this project on the regional system. The amendment is attached.

RELATIONSHIP TO REGIONAL POLICY: Federal law requires that all transportation projects that will be partially funded with federal funds must be in an approved Transportation Improvement Program and meet the following four tests: fiscal constraint; consistency with the adopted regional transportation plan; air quality conformity and opportunity for public input. It is the TAB's responsibility to adopt and amend the TIP according to these four requirements.

PROJECT BACKGROUND:

1. Briefly describe why amendment is needed (e.g. project in previous TIP but not completed; illustrative project and funds now available; discretionary funds received; inadvertently not included in TIP).

A formal amendment is needed to add Project 8217-82045PE for preliminary and final engineering & Project 8217-82045PR for peer review of the bridge design of the St. Croix Crossing in SFY 2012 of the 2012-2015 TIP.

In October 2010 the National Park Service ruled that it could not approve the St. Croix Crossing project under the Wild and Scenic Rivers Act because the direct and adverse effects cannot be avoided or eliminated. This action blocked other federal agencies assistance or permitting actions which effectively delayed the project. On March 14, 2012 President Obama signed legislation that exempted the St. Croix Crossing from the Wild and Scenic River Act enabling the project to move forward.

The St. Croix Crossing project SP8217-82045 (SEQ 1983) is in SFY 2014 of the 2012-2015 STIP with a total project cost of \$345,750,000 including \$89,000,000 in federal funds \$71,000,000 in advanced construction funds and \$256,750,000 in other funds, including \$63,025,000 in state bonds and \$193,725,000 in HPP and bond funds from Wisconsin. This project includes preliminary and final engineering, construction, geotechnical evaluation and surveying among other engineering and tasks. Projects

8217-82045PE and 8217-82045PR are required to confirm and utilize the preliminary bridge plans to produce a formal bridge plan.

Project 8217-82045PE is required in SFY 2012 to design and prepare three separate bridge plans, special provisions, cost estimates and conduct independent review of the hydraulic analysis for the entire-construction project which MnDOT and WisDOT will use to prepare grading plans for the St. Croix Crossing project. Project 8217-82045PR is

required because the State has determined that the St. Croix Crossing Bridges are a major structure, therefore a design review with independent design computations along with detail review will be required for the bridges.

Project 8217-82045PE and 8217-82045PR will be AC'ed with conversion of federal funds from Project SP8217-82045 (SEQ 1983) taking place SFY 2014.

*The federal funds for projects 8217-82045PE and 8217-82045 PR are being AC'ed with conversion taking place in 2014. WisDOT will provide \$7,000,000 for project 8217-82045PE and \$1,250,000 for project 8217-82045PR. MnDOT will use State Bonds to fund the remaining \$1,400,000 for project 8217-82045PE and \$250,000 for project 8217-82045PR. These funds are sufficient to fully fund the project therefore fiscal constraint is maintained.

CONSISTENCY WITH MPO LONG RANGE PLAN:

This amendment is consistent with the Metropolitan Council Transportation Policy Plan, adopted on January 14, 2009, with FHWA/FTA conformity determination established on September 16, 2009. The amendment is also consistent with the 2030 Policy Plan update adopted by the Metropolitan Council on November 10, 2010 with FHWA/FTA conformity determination established on February 23, 2011.


