Proposed Action

That the Metropolitan Council authorize the Regional Administrator to negotiate and execute a Professional Services Agreement with the City of Eden Prairie for staff support for the Traffic Engineer Lead position for the Southwest Light Rail Transit (SWLRT) Project in an amount not to exceed \$300,000.

Background

The Traffic Engineer Lead will report to the SWLRT Engineering Manager and be responsible for providing a variety of activities during Preliminary Engineering and preparation for entry into Final Design. Specifically, the position will provide support for the monitoring and management of SWLRT traffic and traffic-related design; coordination and management of the design consultant to ensure all necessary actions meet the Council's requirements for schedule, cost, quality, and safety; other design related activities as assigned by the design and engineering managers; and weekly communication briefings to the City of Eden Prairie staff to keep them informed on the SWLRT project.

The Traffic Engineer Lead will be located in a workspace at the SWLRT project office. Compensation for services will be paid on an hourly basis for the duration of the Professional Services Agreement not to exceed twenty four (24) months.

Rationale

Professional Services Agreements that exceed \$250,000 require Metropolitan Council action.

Funding

Funds are available in the SWLRT Project budget.

Known Support / Opposition

No known opposition.
