## 2008-222 Authorization to Negotiate and Execute Contract 07P156B for Full Service Interceptor Architectural / Engineering Services

It was moved by Wittsack, seconded by Peterson, that the Metropolitan Council authorize its Regional Administrator to negotiate and execute MCES Contract No. 07P156B with HDR, Inc., for full service interceptor architectural / engineering services for an amount not to exceed \$1 million.

### **INFORMATION**

### Proposed 2009-2018 Capital Program and the 2009 Capital Budget

Bryce Pickart, MCES Assistant General Manager, Technical Services, provided an overview of the process for identifying capital project needs, and reviewed new projects, adjustments to existing projects and estimated costs. The proposed authorized capital program in 2009 is \$1,139,000; the proposed 2009 capital budget is \$159.3 million. The Unified Capital Improvement Program and Unified Capital Budget will be presented to the Council on September 28, 2008.

### **Compliance**

William Moore, General Manager of Environmental Services, reported that as of August 1, all of the wastewater treatment plants achieved 18 consecutive months of complete compliance with permits.

### **Total Maximum Daily Load (TMDL)**

Moore informed the committee that the Minnesota Pollution Control Agency plans to issue draft phosphorus and sediment TMDL for Lake Pepin in November for public comment. If the limit is reduced, it will result in increased capital program costs for the Council to comply.
